## COOKIE POLICY

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website, and also allows us to improve our site.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive and are essential for our website as they enable basic functionalities of the site.

We use the following cookies:

- **Strictly necessary cookies.** These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services. These cookies do not store any personal data.
- **Analytical or performance cookies.** These allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. They are used to help understand how visitors interact with the website. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily by improving content and design.
- **Functionality cookies.** These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region). These will enhance the website performance and functionality. Remembering user preferences boosts website performance and makes browsing easier.
- **Performance Cookies.** These cookies collect information on site performance. They help in delivering a better experience for the visitors. They do not collect identifiable information.
- **Advertisement Cookies.** These provide visitors with customised advertisements based on the pages visited previously. This helps to analyse the effectiveness of ad campaigns.
