



Deforestation and Land-use conversion free policy

At Finnebrogue, we are committed to ensuring that our supply chains are free from deforestation and land-use conversion, with a focus on key commodities that pose significant deforestation risk. Our dedication to the pursuit of this sustainability initiative aligns with our values as a food manufacturing company that strives to produce food that doesn't cost the earth. As a company that produces sausages, bacon, and plant-based alternatives we are intrinsically linked with the environment, therefore we accept responsibility and recognise the importance of protecting global forests, their biodiversity, and the communities that depend on them. As part of our deforestation-free policy, Finnebrogue is committing to the following:

Deforestation-Free Forest Risk Commodities Certification:

We pledge to source key commodities, namely Beef, Dairy, Soya, Palm Oil, Cocoa, and Coffee, through certified supply chains that are free from deforestation and land-use conversion. This pledge extends not only to the sourcing of these commodities as raw materials but also the sourcing of these commodities as components of other sourced ingredients. In principle, we commit to solely work with suppliers who adhere to recognised certifications that verify their products' deforestation-free status.

Certified Deforestation-Free Soya as Livestock Feed:

Though we do not have direct control or ownership over the farms that supply our meat and ingredients we are dedicated to encouraging, collaborating, and demanding that our supply base reduce the use of soya as a feedstock where possible or ensure the use of certified deforestation-free soya as a feedstock within our supply chains. By encouraging the prioritisation of sustainably sourced soya as a feedstock, we aim to minimise our impact on deforestation and support responsible agricultural practices.

Deforestation Cut-Off Date:

Recognising the urgency of addressing deforestation, we have set a deforestation cut-off date for our supply chain activities. We commit to no longer source ingredients or products which have been produced on land that has been deforested or have undergone land-use conversion after the year 2020. This ensures that our current and future sourcing practices do not contribute to recent or future deforestation practices.

Target for Deforestation-Free Supply Chains:

Our ultimate goal is to achieve deforestation-free supply chains by the year 2025 for the direct purchase of forest risk commodities, and for a full transition to verified deforestation-free livestock feed within our supply chains. We will work collaboratively with our suppliers, stakeholders, and industry partners to implement sustainable practices, enhance transparency, and continuously improve our supply chain sustainability initiatives.

Transparency and Reporting:

We are committed to providing transparent information regarding our progress towards deforestation-free supply chains. Regular reports will be published to share updates on our journey



to achieving a deforestation-free supply chain. These reports will include metrics, challenges faced, and positive outcomes from collaboration efforts with supply chain partners.

By adopting these commitments, Finnebrogue aims to contribute to the preservation of global forests, biodiversity, and the well-being of communities worldwide. We recognise that a deforestation-free supply chain is crucial for a sustainable future and are dedicated to leading positive change within our industry.
